
CORRIGENDUM/ ADDENDUM

In such cases, to safeguard the data, the agency shall transfer all the responses/ answers marked by the candidates, appearing in the Examination within one hour of completion of Examination. Rest of the data like Biometric, Photograph etc. shall be transferred to ASRB as soon as possible but not later than 5 days after the examination is over. All the data must be deleted from the server of agency after transferring it to ASRB in a secure mode. Audit in this regard can be made at any time.</p> |
